Certificate	A payment of DKK 100.00 will be charged
Certificate including marking of the product (only relevant to Steel and Metals)	A payment of DKK 200.00 will be charged
Certificate with a certificate of inspection	A fixed payment agreed for the work carried out and the document will be charged
Flex box delivery under the applicable terms on www.ahlsell.dk	Depending on the volume and distance a payment in the range of DKK 149,00-499,00 will be charged
Express delivery from Billund under the applicable terms on www.ahlsell.dk	For orders of Products from our central warehouse in Billund, a payment in the range of DKK 299 – 2,499 will be charged. Express delivery can be ordered Monday to Thursday between 07.00 – 16.00, and by 14.00 on Fridays. We deliver throughout the country – however, only to islands connected by a bridge or causeway. If crane delivery is required, this will be invoiced separately based on actual costs.
Cutting	A payment ranging from DKK 44.00 will be charged for cutting of Steel and Metals
Cutting of hoses and cables	For the handling and cutting of hoses and cables, a fee of DKK 100 will be charged
Processing/customisation	A fixed payment agreed for the work carried out will be charged
24-hour service under the applicable terms and conditions on www.ahlsell.dk	A payment of DKK 1,400.00 per case excluding transportation costs will be charged
Paper invoice	A payment of DKK 39.00 for forwarding a paper invoice will be charged per invoice
